Minutes of the meeting of Churt Parish Council held on Wednesday 15 January 2020 in the Churt Pavilion at 7.30 p.m.

#### 20/01 Chairman's welcome

Cllr Crossley welcomed all to the meeting and invited the members of the public to speak. Stuart Turner is the new owner of Green Cross Farm. He bought 11 acres of land but the Whitcombes kept about 30 acres and the farm cottage. The Hillberrys also bought some acreage.

The main barn and dairy are Grade II listed. Will be submitting a planning application for a new farmhouse on the site. Plans and application already in for dairy and barn.

Cllr Martin has emailed Stuart Turner with various concerns, the main being will the 3 buildings be held as one title? ST confirmed they would and he planned to rent out 2 of them in order to keep control over who his neighbours were!

Extensive surveys and bat surveys have been carried out and he plans to use bat boxes and special ridge tiles in the new build.

Cllr Johnson asked what his plans were for the 11 acres - pony, chicken and sheep.

Cllr Crossley confirmed the housing needs survey carried out a few years ago highlighted only a small need for affordable homes in Churt which would be met by the proposed WBC development.

Cllr Crossley also asked about traffic surveys? SCC Transport Development Control would be asked to comment on any new applications.

Cllr Crossley asked if the new house would be on the same site as the old farmhouse? - yes. The Grade II listed barn would be refurbished to look as it originally would have done and an ancient pond would be restored in the middle of the farmyard.

Cllr Crossley commented that the PC was pleased there was no commercial bias.

Cllr Harmer(SCC) confirmed the first draft of the potential budget for next year is now online and it is deemed an expansionist budget, taking advantage of preferential rates to borrow money long term.

3 main areas to use money:

- 1) Highways expansion of current Horizon programme to construct roads to last for 50 years with surface dressing at 20 and 40 years.
- 2) Special education needs facilities Many parents face significant journeys to special needs schools for their children. Those with physical needs tend to face the longest journeys. Majority of schools have a SENCO. Target is to build 2 new schools for physical needs and expand facilities within existing schools. £14-£15 million spent a year transporting children to these schools.

3) Adult social care - construct more facilities for protected living. Cllr Johnson commented that some care homes were shutting down as no longer viable. The largest problem in Waverley exists in Cranleigh. There will be a 2% surcharge for adult social car and a 2% surcharge for everything else.

Following recent high winds there were trees down all over Surrey. The first priority is to clear trees to allow emergency vehicle access and the second priority is to ensure safety. A287 near Pond Lane deemed unsafe due to flooding. The current 4 inch drain is blocked and cannot cope.

Cllr Johnson mentioned the blocked drain along Barford Lane - Clerk to email Steve Lindsey-Clerk at SCC.

Safety issue on corner of Barford Lane and the A287, dangerous for children and parents walking 2 abreast along there. Needs a raised pavement in front of Honda Garage.

Cllr Potts (WBC) - looking to deliver a balanced budget with a 1.99% council tax increase. New waste contract with Biffa bedding in well.

WBC has contracted a new head of planning and economic development, Zak Elwood, previously at Guildford BC. He wants to rebuild a good relationship with the parishes. Appreciates that many case officers work part time. Intends to train parish clerks on planning matters.

# 20/06.2.1 Jumps Road parking (KL) (Item taken out of order whilst Borough and County Councillors were still present)

At the meeting held in December the Sculpture Park confirmed they might look at the piece of land to the right of the Bel and Dragon. This is farmed by the Platfoots and they do not wish to sell it.

There was a hit and run accident just after Xmas when a car was badly damaged.

Cllr Law suggests a 'rural clearway' as the solution or some form of parking restriction.

The Sculpture Park covers 10 acres of land plus storage land. Richard Bourne commented it would be possible to park 20-30 cars on the current storage site.

Is there a request into parking department at SCC for recommendations?

Cllr Harmer would prefer a rural clearway.

Cllr Crossley requested Cllr Harmer update Frensham PC at their parish meeting.

Sculpture Park has updated their website highlighting the rural highways but still suggest there is plenty of parking.

Cllrs Harmer and Potts left the meeting.
