# Minutes of the meeting of Churt Parish Council held on Wednesday 18 March 2020 in the Churt Pavilion at 7.30 p.m.

## 20/23 Chairman's welcome

Cllr Crossley welcomed all to the meeting and invited the guests to speak. He gave a precis of the newly formed Grayshott Covid 19 group, chaired by Phylicia Andre. An emergency meeting was held the previous Sunday and we now have a system in place to help the vulnerable in Churt. There has been a huge mail drop to clubs, societies, mailing lists etc. Cllr Law has produced a legal disclaimer protecting both the volunteers and those requiring assistance.

Cllr Crossley introduced Jo Corfield, the Covid 19 Churt Community Support Group coordinator. She confirmed that Churt has a good base of volunteers. Requests for help come into the Grayshott call centre and are then forwarded to Jo who puts the request out to the Churt volunteer list.

Still working on flow charts as to how to best streamline this process, which is very fluid in nature.

Cllr Adams requested that WBC is alerted to any really vulnerable people and he will feed back what we are doing to Tom Horwood.

Dockenfield and Frensham Churches are coordinating their area.

If children are involved need to ensure the volunteer is DBS checked.

Disclaimer up on the Covid 19 Facebook page.

Cllr Crossley proposed a special vote of thanks for the hard work put in by Cllrs Law, Johnson and Dawn Barrow, Parish Clerk, plus Phylicia Andre and Jo Corfield.

We are aware that supermarkets are imposing limits on some purchases and it is good at a time like this to support local shops and businesses.

Cllr Harmer (SCC) advised the last SCC meeting was on 17 March, delegation process in place due to Covid-19, most decisions can be taken with no change to legislation. 15 people took part in an electronic meeting which worked well. Next full meeting will be at County Hall in October. New protocols will be put in place, monitored by the audit and governance committee. Schools are closing but no decision yet re libraries.

Priorities are that roads stay open and utility companies still go about their business. Need to get a waiver from Waverley in order to postpone annual assembly. Suggest we write asking for a postponement to 31 May in the first instance. The public have the right to attend this meeting so it may be suspended for 2020 (TBC). Tilford have already postponed theirs.

Other matters: Corner of A287 and Jumps Road, potholes mended 18 March. Proposal for yellow lines down far end of Jumps Road agreed by joint committee. Proposal for a rural clearway will

be determined by a central body. If we are to write in with an objection Cllr Harmer advised best to concentrate on the yellow lines.

Richard Bourne confirmed the next meeting regarding the parking issues along Jumps Road is scheduled to take place in June. Consultation process needs to move ahead in advance of this meeting.

Cllr Crossley confirmed that the best outcome would be for the provision of a proper car park.

Cllr Adams (WBC) confirmed the revised plan for Farnham went through this week. The Government have released a new housing paper.

RE: 'dark skies' there is not much allusion to this in the AONB management plan.

Colin Wiskin advised that CCC have been promoted and need to now provide an umpires room. 2 thoughts:

- 1) Build a small wooden building behind the cricket nets, cost c. £33,000
- 2) Convert back room as you enter the garage and knock through to the main part of the pavilion, cost c. £30,000

Grants should be available for this from ECB and Playing Fields Association. Colin will tell Surrey Cricket the matter is in hand.

Cllr Crossley advised Council not keen on option 2 as this area is used as storage for other societies as well as for the Council's emergency equipment.

Due to Covid 19 it is unlikely there will be any cricket this year, this will impact on the rental the CCC pays the Parish Council.

The Ian Christie Cup is in hand for the juniors.

Cllr Crossley then **proposed** that Adrian Waller stays on as webmaster at  $\pm 40$  per hour (possibly 2/3 hours per month). **Seconded** by Cllr Burch, **all in favour**.

Dominic Raeside has said he is interested in standing as a councillor to fill the vacancy. **Proposed** by Cllr Crossley, **seconded** by Cllr Rowe, **agreed by all**.

Dominic Raeside was duly co-opted onto the Council.

### 20/29.1.1 Report from Environment Working Group (MJ sent report)

Inaugral meeting of the CHEWG on 26 Feb. Terms of Reference agreed. Churt action plan should follow the WBC climate strategy. Ongoing discussions re the future of the land at Pond Lane, speeding measures for the village, anti-pollution initiatives and tree strategy.

Next meeting planned for April but this may need to be a virtual one.

### 20/29.1.2 Village centre portfolio (RC)

Signs put up supporting the fun run but now taken down.

Cllr Martin's son is still litter picking and noted how bad litter was along Barford Lane. Responsibility for monitor littering now lies with WBC, they can film culprits via webcam. Large hoarding up in front of Jacobson House, they have planning permission for 3 dwellings

### 20/29.1.3 Crime and Disorder (RC)

Moreton House and 3 other houses broken into along Hale House Lane plus the village hall shed.

### 20/29.2.1 Jumps Road Parking

Jack Roberts (SCC Parking team) suggests that double yellow lines from sculpture park to Woodside would be feasible. Malcolm Young has commissioned an independent traffic survey to show that double yellow lines may not be ideal. His preferred option is for a rural clearway. Katy Law's husband together with Sean Willis from Frensham PC and Cllr Crossley attended the joint committee meeting 13 March. There are now over 50 signatures on the petition from Jumps Road residents. However this was presented too late to be included in discussions. Double yellow line proposal now out for consultation. Sean Willis to write to the planners at Waverley BC.
