20/81 Chairman's welcome

Cllr Crossley welcomed all to the meeting and invited the guests to speak.

Cllr Harmer confirmed that County Hall will be vacated by Xmas and SCC will be moving to a building near Reigate. Part of the old County Hall will become part of Kingston University and will be used for education, the rest for residential and public services.

Re. Government's active travel programme, this year's money will be used for towns and next year's for outlying villages. Critical to find safe routes for children to get to school.

Waverley cycle forum useful for showing cycleways.

Tilford East Bridge will reopen in next couple of weeks.

Cllr Crossley thanked Cllr Harmer again for his SCC grant towards the cedar bench.

Richard Bourne stated that people need to respond to SCC about how they envisage the parking improvements near the Sculpture Park. Now out for public consultation.

Enforcement notice has been served on the SP on 6 October, effective from 6 November. They then have 6 months to rectify issues.

Cllr Cordell stood down following September's meeting and has been presented with the customary Frances Frith print of Churt and a letter of thanks.

We have 2 outstanding applicants for the vacancy, Sally Shorthose and Leslie Sharp. Cllr Crossley invited them both to speak.

Sally has lived around Churt for more than 30 years and in Churt itself for the last 7. She feels it is a very special community with great vision. Her husband is a governor at St John's School. She works as a solicitor but puts a lot into the community. Is happy to be a team player or a leader. Has helped extensively at Woolmer Hill Sports Association.

Leslie has recently been involved in the planning issue at Furze Hill Stud and has lived between Churt and Haslemere for the last 30 years. Very interested in technology, the environment and green issues. Happy to join the environment working group if not voted in as a councillor. Cllr Crossley invited both to leave the meeting but said they could stay if they wished.

Sally was voted in as the new councillor with 5 votes to 3. (3 by proxy)

Portfolio responsibilities:

Chair of recreation ground committee - Cllr Crossley proposed Cllr Burch become the new chair, seconded by Cllr Rowe, agreed by all. Cllr Crossley suggested Sally joins the playground inspection rota.

Cllr Rowe will take on the village centre portfolio and Cllr Raeside will head up crime and disorder and open up lines of communication with the new police inspector.

Clerk to provide Cllr Raeside with various contacts and local policing and crime links.
