Farnborough Airport - new consultation

You may have heard that Farnborough Airport has launched a public consultation to gather feedback from local communities on the Airport's future growth plans. This includes an increase in the number of annual flights from today's cap of 50,000 flights per year to 70,000, and a doubling of movements at the weekend.

We discussed our response to this consultation at our September meeting, and were grateful to several members of the public who attended and provided expert input. We resolved to make a formal submission to Farnborough Airport objecting to their proposals for an expansion of the airport operations.

The Council believes that if the requested increase in annual flight limits is permitted it would more than double current Farnborough flight movements (32,500) and it would considerably increase the noise pollution already suffered by Churt residents.

The Council also felt that the emissions from these flights would cause significant harm to residents and to the outstanding natural environment which surrounds Churt, would be a retrograde step in trying to achieve net-zero carbon emissions as well as being incompatible with the aspirations set out in Churt's Environmental Charter: Net Zero by 2050.
